GAINS FROM THE PERSPECTIVE OF TURKEY

- By becoming a member of EU, Turkey will strengthen its political and strategic presence, increase its effectiveness and secure its interests.
- Turkey's entitlement for membership within the framework of executed documents with EU will be based on solid ground.
- Turkey, with EU membership, will further develop its international economic and commercial interests and will secure its future in this field.
- EU membership will reinforce the judicial order that modern life requires, and will open up new frontiers for our youth in the field of education.
- EU membership will contribute to increasing the status of our citizens in Europe.
- Membership to EU will lessen anti-Turkish prejudice and negative perceptions that have been built up for centuries.
- EU membership will allow democracy to become more solidly entrenched by speeding up the process of the development of in our country.
- The basic system of the Republic will be

secured; the period of Military Interventions will be completely over. Civil Society Organizations will come forward.

- Turkish Armed Forces, by the mediation of NATO and European Army, will be able to play a vital role in Europe.

- Full membership will have a strengthening effect on Turkey's defense and security policies.

- Turkey will be able to play an important role in shaping the situation on such of Europe since it will join Europe's decision-making mechanisms. In this situation, the presence of Turkey in the Middle East, Central Asia and Southeast Asia will increase, and will have an extremely exceptional and influential place in the Islamic World. Turkey will be able to influence much more activities in these areas.

- EU membership will increase the level of employment with economic growth by providing the necessary medium of stability.

- By becoming active and working effectively the state will offer more services in areas of health and justice. With the arrangements made in many areas concerning the society the living standards of our citizens will improve.

- Full membership will have a positive effect on the consumers by contributing to improve the concept of quality in Turkey.

- The professional standards in Turkey will be aligned with EU standards.

- By harmonizing with EU legislation, the competitive power of our firms will increase.

- The inclusion of Turkey in EU Justice and Home Affairs policies will strengthen the fight

against terrorism, drugs and illegal immigration.

- Full membership will play an important role in the development science and technology in Turkey.

- Turkey's full membership to EU will contribute to reform of the agricultural sector.

- Full membership will speed up the development of Turkey's tourism sector.

- The participation of Turkey in trans-European networks with full EU membership will be beneficial especially in the areas of telecommunication, transportation, energy and environment.

- Turkey's full EU membership will strengthen the process of establishment of a participatory and democratic political culture and civil society at Western standards in the country.

- Full membership will have an enriching and developing effect on the cultural structure of Turkey.

- The participation of Turkey in the Regional Policy of EU following membership will significantly contribute to lessen regional disparities in the country.

- Demographic advantage will be a political power for Turkey regarding the EU.

- The situation of Turkey, which currently is a "role model" for the countries of the Middle East, will be strengthened further and will increase its significance in this region.

- Harmonization with EU technical legislation with full EU membership will have an increasing effect on the competitive power of Turkish firms.

- Membership of Turkey will allow the EU to be transformed into a global actor.

- Turkey's membership will also contribute much to Europe from the economic perspective.
- Membership of Turkey will strengthen EU's domestic market and its competitiveness in markets.
- Turkey as an EU member will bring greater political dominance for the EU and a wider range of security to Europeans.
- Turkey's accession to the EU will be able to alter EU's strategic status in the world in its favor.
- Turkey's accession will extend a new horizon for EU and expand its vision.
- With the completion of Baku-Ceyhan pipeline, Turkey will ensure the access of the EU to this resource.

- With Turkey's membership, the position of EU will change in the Islamic world. The "Christian-Muslim conflict" claims after September 11 will be mainly eliminated. On the contrary, it will be able to show the world that cultural differences can get along; Islam can be compatible with modernism and democracy. Turkey's membership will influence the vision of Islamic world of Europe and West in general.

- According to calculations, in 20 years Turkey will have a population of 85 million and per capita income of 10000 dollars. A growing, young and dynamic Turkey will be a very important market for EU.

- Turkey's young population will make supply for the manual labor that Europe will need.

- The lack of area for the expansion for industry in Europe will be eliminated.

- Turkey's full membership will contribute to the EU's increasing the effectiveness of its policies in the area of Justice and Home Affairs.

- With full membership of Turkey the Aegean becoming an inner sea of the EU will be a strengthening effect on the strategic interests of EU.

- Full liberalization of services and public procurement that will be provided after full membership will bring significant advantages to EU firms.

- Full membership of Turkey will provide significant opportunities to EU firms with respect to direct investments.
